

3. No Colleges shall conduct their own CET test for admission for any course of University unless it is an autonomous college.




Minority Status Recognition Certificate


Nirmala Memorial Foundation, Thakur Complex, Adjacent to Thakur Polytechnic, Kandivali, Mumbai, an educational institution submitted an application on 1.10.2007 for recognition of the status of their institution as a Linguistic Minority Educational Institution. On 14.07.2008, on the basis of the presentation made by the office bearers of the organization during the hearing held before me with the concerned organization, the said organization Minority Development Department, Government Decision, no. Ashes-2008/Pro.No.133/2008/Ka.1, dt. 4th July, 2008 I am satisfied to be established and operated by a person or a community of persons from among the linguistic (Gujarati) numbers declared by the State Government under the criteria prescribed. Consequently, the said institution is hereby declared to be a linguistic (Gujarati) minority educational institution.

This certificate will be applicable only for the state of Maharashtra. The linguistic numerical status awarded to the said institution shall be applicable to all the academic branches operated by the institution.

The Linguistic Minority Status hereby granted to the above mentioned educational institution shall be valid from the academic year 2008-09. The concerned body has issued the Minority Development Department, Government Decision, no. Ashansam-2008/Pro.No.133/2008/Ka.12. It will be mandatory to consistently and specifically fulfill the criteria prescribed vide July 4, 2008.
